### Cookie Policy

As the Turkish Contractors Association (TCA), we show maximum sensitivity to the processing and protection of the personal data of the visitors of our website (www.tmb.org.tr) in accordance with the Law on the Protection of Personal Data No. 6698 and its secondary regulations.

Within the scope of the disclosure obligation arising from the Personal Data Protection (KVK) legislation of our Association, we would like to inform you about the cookies used by our Association and your personal data processed through this TCA Cookie Information Text.

**Turkish Contractors Association does not process any of your personal data through "cookies".**

#### What Types of Cookies Do We Use?

Cookies are small text files created on your device by a website and contain data in name-value format. Therefore, the cookies we use when you visit our website make it possible to store information about your visit to the website on your device and to use this information during your next visits.

Cookies created by our website are **primary cookies**.

The content presented on our site is also provided through domain names other than the domain name in the access address. In such cases, each domain name creates its own unique third-party cookies.

**The types of cookies we use on our website and our purposes for using these cookies are as follows:**

**Session Cookies:** Session cookies are cookies that are valid during your use of our website and remain valid until you close your internet browser.

**Persistent Cookies:** These are cookies that are stored in your browser and remain valid until they are deleted by you or until their expiration date.

**Compulsory Cookies:** These are the cookies that are mandatory for our website to function properly and for you to benefit from the features of our website and the services offered.

**Functional and Analytical Cookies:** These are cookies that contain data about remembering your behavior and preferences during your visit to our site, using our site effectively and how you use the site. By means of these cookies, for example, your language preference for the display of our site is processed.



With the third-party cookies we use on our website, we aim to provide you more efficient and functional internet experience. The Personal Data Protection (KVK) Confidentiality Agreement has been concluded between these third-party service providers and our Association in accordance with the Personal Data Protection (KVK) legislation, and the security of your personal data obtained by these persons on behalf of our Association is guaranteed.

### **Storing and Accessing Cookies**

Cookies created by our website are stored on your computer by the browser you use to access our website. Remote access to the information contained in these cookies is possible only by our website, which is presented under the domain name (www.tmb.org.tr) that created the cookie, and if you use the same browser.

### **It's Up to You to Accept Cookies**

Your internet browsers usually automatically accept the cookies used on the websites you visit. The use of cookies is not mandatory to use our website, but if you set your browser to block all cookies, the quality of your user experience may decrease and it may prevent you from accessing our site or benefiting from various functions of our website.

You can configure your browser to block cookies for all or specific sites, alert when cookies are set, block third-party cookies, or treat all cookies as session cookies.
